TERMS AND CONDITIONS

- In these terms and conditions “we/us/our” means Brighton and Hove Albion Football Club Limited, a company registered in England (company registration number 00081077), whose business address is at American Express Stadium, Village Way, Brighton BN1 9BL, and “you/your” means the person booking the Young Seagulls Birthday Party.
- The minimum booking is £300 or 15 children and the maximum is 30 children £500.
- A maximum of 4 free adult places are available to accompany the children; we are unable to add on more adults due to stadium restrictions.
- We are not able to accept bookings on Bank Holidays or home matchdays.
- Bookings may be rearranged/cancelled due to stadium accessibility.
- Bookings cannot be accepted less than 7 days before the party date.
- Extra guests are payable at £20 per head. We are unable to add on extra party guests less than 7 days before the party date.
- Your confirmation letter will include confirmation of the amount you have paid.
- Catering is sourced to a local bakery; therefore, if there is any allergies that we need to be aware of please detail this in writing no later than 7 days prior to the party.
- Full payment must be made at the time of booking.
- The party includes:
 - The current Albion replica shirt with name and number printing.
 - Behind-the-scenes tour
 - Party food
 - Birthday cake
 - 2 hours’ supervision with a party host
 - Interactive activities, including TV presenting, interviewing and commentating.
- All data supplied will only be used for the purpose to which it is intended and in accordance with our Privacy Policy (details available at BrightonAndHoveAlbion.com) and will not be passed to any third parties.
- In the event of a rescheduled home game or any additional home games throughout the season clashing with the agreed date, parties will need to be rearranged for an alternative date.
- In the event that the stadium and the facilities may be booked out by an external party and the date clashes, parties will need to be rearranged for an alternative date.
- We reserve the right to cancel the party within 24 hours. In such circumstances we will provide an alternative date for the party or an option of a full refund. If we cancel a party with 7 days’ or more notice we will offer an alternative date for the party.
- Parties cancelled by you within 7 days of the event will incur a 100% cancellation fee. Parties cancelled within 14 days of the event will incur a 50% cancellation fee.
- We will not be liable for loss or damage to any property brought on to the premises or left at the premises by you or any member of your party.
- We will not be liable to you, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, for any loss of profit, or any indirect or consequential loss arising under or in connection with these terms and conditions, and our obligations to you and our total liability to you in respect of all other losses arising in connection with these terms and conditions and our obligations to you, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, shall in no circumstances exceed the party booking fee.
- Nothing in these terms and conditions shall have effect to limit or exclude liability for personal injury or death or for fraudulent misrepresentation. These terms and conditions do not affect your statutory rights as a consumer.
